### At NZMHA Member Only Shows:

- All exhibits/horses must be registered with NZMHA and be owned/leased by a current financial member of NZMHA;
- Only current financial members of NZMHA are eligible to enter the show ring as of right. All other persons must have been nominated on a handler registration form which must have been lodged with the NZMHA Registrar and the fee paid before the closing of entries for the first show in the show season at which the handler will be participating;
- **Note:** Handlers are not eligible to enter handler classes
