- ✓ This transfer report must be completed in its entirety – front & back - No boxes should be left blank. If any information is unknown please write "unknown" in the box;
 - ✓ The colour and markings of the horse should be checked against the description of the Registration Certificate;
 - ✓ Please include two (2) current full body colour photographs showing all markings on both sides and one (1) of the head (from the front) showing complete face markings and whorls (pull forelock to one side). The image of the horse must be no smaller than 7.5 nor greater than 10 cm square. Original photographs only are acceptable; digitised scans or laser copies are not acceptable. Markings must be clearly visible. No other horses should be shown in the photographs;
 - ✓ Send the completed Transfer Report, the prescribed fee (refer to Tynytales or www.nzmha.co.nz) and the ORIGINAL Registration Certificate to the Registrar no later than sixty (60) days after the date of transfer otherwise a Transfer Penalty will be payable;
