### Membership Options

**Regular Membership:** Payable by individuals who own an interest in or lease an NZMHA registered horse.

Ensure you include the Horses name and NZMHA registration number. Each Regular member over the age of 18 years is entitled to ONE Vote at a general meeting of members.

A **discount** is available for the second and subsequent members residing at the same address.

**Associate Membership:** Available where the member does not own or lease a NZMHA registered horse. NO voting privileges.

**Youth Membership:** Available to persons under 18years. NO voting privileges. Please ensure you include the name and Date of Birth (DOB) of each Youth member.

**Please Note:**

-Application Fee- The Application Fee is payable in addition to the annual subscription in your first year of continuous membership only. It is to cover the costs of processing your application and providing you with all of the information that you need as a member.

-Part Year Membership - The Subscription year runs from 1 September each year. If you join between 1 September and 1 March, you will pay a full year subscription. If you join after 1 March but before the Annual General Meeting in July, you will pay HALF of the annual subscription. Persons joining after the AGM pay new year's rate that covers through to September 1 the following year.
